Official Rules

1. **Raffle.** Stars & Stripers Fishing Tournament Online Raffle (this "Raffle").
2. **Raffle Period.** This Raffle begins at 11:30 a.m. on Thursday, May 2, 2019, and ends at 11:59 p.m. on Monday, June 3, 2019 (the "Raffle Period").
3. **Eligibility.** Raffle only open to individual legal residents of the fifty (50) United States (excluding CA, FL, NY, Puerto Rico, territories and possessions) who have attained the age of majority in their state of residence as of the date of entry into the Raffle. Employees of the New England Patriots Alumni Club Inc., New England Patriots Foundation Inc., the Kraft Group Companies, and each of their respective affiliates, officers, directors, employees, agents, advertising, public relations and promotion agencies, the judges, and members of each of their immediate families (i.e. spouses, parents, children and siblings, and their respective spouses) and those living in the same household of each are not eligible to enter.
4. **Raffle Tickets.** Raffle tickets may be purchased for Ten Dollars (\$10.00) online at www.patriotsalumni.com. There is no limit on the number of raffle tickets sold. Raffle tickets are transferable or assignable. Upon entry, entrant will receive a receipt which shall constitute a ticket for the purposes hereunder. Sponsor may require entrant to present the receipt in order to claim prize.

100% of proceeds from the Raffle will go to the New England Patriots Alumni Club Inc., a 501(c)(3) not for profit corporation, supporting retired Patriots while working together toward its goal of supporting youth football in New England.

Prizes are not redeemable for cash and may not be used on alternate dates. No substitutions of any aspect of the Prize by winner will be allowed. The drawing will be conducted by the Sponsor, whose decisions are final on all matters relating to this Raffle.
7. **Prize Delivery and Winner Verification.** Sponsor responsible only for prize delivery; not responsible for prize utility, quality or otherwise. Winner will be notified by telephone and or email. If a potential winner cannot be reached by telephone and/or email within a reasonable time of the drawing or is ineligible, the prize will be

forfeited and an alternate winner selected. Winner will be required to sign and return an affidavit of eligibility, prize acceptance form and applicable tax documentation. Winner may be required to sign an affidavit of eligibility and liability release and, where permitted, a publicity release. Prize may be awarded to an alternate winner if affidavit/release(s) is not returned within eight (8) hours of the time of first attempted notification. By participating, entrants hereby release and agree to hold harmless the New England Patriots Alumni Club Inc. and the Kraft Group Companies, and each of their directors, employees, officers, and agents, including without limitation, their advertising and promotion agencies, from any and all liability, loss or damages arising from or in connection with the awarding, receipt, and/or use or misuse of the prize or participation in any prize-related activities.

Any and all legal actions or claims arising in connection with this Raffle must be brought in a court of competent jurisdiction within the Commonwealth of Massachusetts. Except where prohibited by law, each entrant agrees that: (i) any
